## 2024 Idaho Mt. Lion, Wolf, Moose Hunts

Seasons, Dates, and Prices

### *Mountain Lion/Wolf Combo Hunts*

- ◇ Our Mountain Lion/Wolf Combo Hunts take place right at the onset of Winter During November & December
- ◇ 1:1 Hunter to Guide/Houndsmen Ratio
- ◇ Common Vehicles are Snowmobiles, Tracked Side-by-Sides, and 4x4s
- ◇ We depart each morning at sunrise and travel roads until fresh tracks are found. Then we set the hounds loose to tree the Mountain Lion. Snowshoes may be required
- ◇ Wolf Hunts are conducted using Idaho approved expanded hunting methods, via electronic calls and incidental spotting
- ◇ Reduced Rate Tags! Mountain Lion = \$41.75 Wolf = \$31.75



**6-Day Mt. Lion/Wolf Combo Hunt (Mon-Sat) \$5,300 + 6% Sales Tax = \$5,618 Total.**

### *Idaho Moose Hunts – Any Weapon Season*



- ◇ Shiras Moose Hunting in Idaho is only available via controlled hunt
- ◇ Moose Tags must be applied for in April of each year with Draw results posted around the first of June each year
- ◇ Applicants must pay in full the cost of license and tag during the April application window
- ◇ We encourage hunters to visit the Idaho Fish and Game Website for more information. <https://idfg.idaho.gov/rules/moose-sheep-goat>
- ◇ Dates and Prices can be coordinated prior to the Application Window or after the Tag Results are posted.
- ◇ Controlled Hunt Application Fee = \$45.75
- ◇ Idaho Non-Resident Moose Tag = \$2,626.75
